

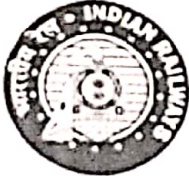

**Sub: Precautions for Crew during Blackout and Siren Alert.**



To ensure safe train operation during siren alerts or blackouts, the onboard Loco Pilots should follow the instructions given below-

**Once the LP comes to know about blackout/siren Alert, he has to-**

- a. Dim the headlights of locomotive and proceed cautiously as per signal aspects.
- b. Proper & adequate use of whistling during section and while approaching LC gates, entering to station yard & at platform.
- c. Switch off all interior lights of locomotives visible externally to minimize visibility.
- d. Reduce the speed to a safe level depending on the track visibility, curvature, gradient & or as per his discretion.
- e. Stay calm, vigilant, and fully alert throughout the blackout condition.
- f. Use the available communication channels to report any unusual incidents to TLC.
- g. Keep the emergency tools and personal safety gear within reach (first aid kit, whistle, torch etc.)
- h. Crew may carry their personal kit having emergency non-perishable food and drinking water, medicines etc.
- i. Conserve the battery power of locomotives by switching off non-essential electrical equipment during extended halts.
- j. Observe the surroundings carefully for any signs of aerial activity, explosions, or suspicious movement. Record the time and direction of such events and report them immediately to Control/Train Manager.

During Blackout/Siren Alert., the above instructions are very much needed as a precautionary measure and safe train operations. Therefore, it is directed to get the above instructions followed by on duty LPs meticulously.
