Sub: Drive no. 10 (FY 2025-26) : 15-Days Safety Inspection of block section Level Crossing gates over Indian Railway

Ref: (i) This office letter No. NWR/HQ/Safety/SD/20/25 dated 09.07.2025

(ii) Railway Board's Letter No. 2025/Safety-1/3/7 dated 08.07.2025 (Copy enclosed).

Vide above referred letter at Sr. No. (i), safety drive no. 20/2025 To ensure Safe working on non-interlocked manned level crossing gates. ("Closed to Road Traffic" & Open to Road Traffic) was issued. There is a revision advised by Railway board in this drive vide referred letter at sr. no. (ii).

Therefore, following aspects are to be checked in this safety drive for 15 day (with effect from 09.07.2025 to 23.07.2025). During the safety drive, officials should pay special emphasis on the following aspects: -

- i. Exchange of private nos.
- ii. Filling of records.
- iii. Position of Height Gauge, Speed Barrier, Road Surface and Signages
- iv. Knowledge of gateman especially regarding gate protection.
- v. Visibility of lifting barriers from operation winch/panel.
- vi. Audio recording facility available and working at all non interlocked LC gates.
- vii. Availability of essential equipments as per GWR.

The above list is indicative only; Divisions may include other items as per their practice. In this drive , officers and supervisors of all technical departments may be involved.

Effective action must be taken on all deficiencies and irregularities noticed in the drive. Sr. DSOs may also critically analyse shortcoming to identify systematic deficiencies and action taken/planned shall be sent to this office daily by 9.00 hrs (As per standard proforma enclosed as Annexure A).

During drive, all concerned officers & supervisors may be involved to cover all LC gates of block section under their jurisdiction. The inspections should be filled in prescribed Google form on daily basis.

Please find the under-mentioned Google Form to be filled during the above inspections of all level crossings. The position shall be put up to GM/NWR and Railway Board in daily basis.

It is also requested that wide circulation of below mentioned Google Form link may be done so that the details of inspection done by all officials may be compiled.
